



Of those Dues, Administrative Dues of (\$1.35) for First Year Apprentices and (\$1.85) for all other classifications will be sent from the Joint Trust Depository directly to District Council 16. First Year Apprentice Dues of (\$1.35) is comprised of DC16 Dues Check-Off (\$1.10), Local Union Dues (\$.15) and United Association Organizing (\$.10) All other classification Dues of (\$1.85) are comprised of DC16 Check-Off (\$1.10), Local Union Dues (\$.65) and United Association Organizing (\$.10)</p>

<p>(***) NOTE: Apprentice 1, Apprentice 2, MES & Tradesman H&W amount is \$.50 higher which goes into their HRA account because they do not have a Pension. All other classifications lowered their HRA and moved their \$.50 to Pension</p>														
<p>NOTE: The Employer shall pay to the ARCA/MCA Promotion Fund \$.38 per hour worked for all classifications under this Agreement. That amount, which will be included in the "Composite Rate" is to be sent to the Joint Trust Depository.</p>
