




The per employee amount which is included in the "Composite Rate" is sent to the Joint Trust Depository. For classifications paying (\$2.75) Dues, are comprised of District Council 16 dues check-off of (\$1.10), Local Union 250 Dues of (\$.65) and Local Union 250 Retiree Christmas Bonus of (\$.90) and United Association Organizing (\$.10) For classifications paying (\$2.10) Dues, are comprised of are District Council 16 dues check-off of (\$1.10) and Local Union 250 Retiree Christmas Bonus of (\$.90) and United Association Organizing (\$.10)													
(****) National Pension Plan Apprentice, First Three Years MES & Tradesman Contributions should be 50% of Journeyman National Pension. The National Pension funding improvement plan (FIP) filed with the IRS notes \$.76 cents therefore the National Pension Contribution for Apprentice, First Three Years MES & Tradesman at this time are \$.76													
(*****) Refer to 11.02-F for Probationary Period application (*****) Tradesman Wage comes from CA Labor Code SB3 (minimum wage)													
NOTE: The Employer shall pay to the ARCA/MCA Promotion Fund \$.38 per hour worked for all classifications under this Agreement. That amount, which will be included in the "Composite Rate" is to be sent to the Joint Trust Depository.
